Supplemental and Social & Environmental Assessment Balecbec-Basca Road and Balecbec Bridge, La Union April 06, 2015

I. DA-IPM (Department of Agriculture-Integrated Pest Management –Kasalikasan)

The Provincial Government of La Union and Municipal Local Government Units (MLGUs) in partnership with the Department of Agriculture-Region I regularly conducst commodity-based Farmer Field School (FFS) with Integrated Pest Management (IPM) as part of the course in various municipality.

However this is not yet being implemented at Brgy. Balecbec, Naguilian and Brgy. Basca, Aringay, La Union. The Office of the Provincial Agricultulrist will ensure that DA-Kalikasan be integrated in its Annual Work Plan and the corresponding Annual Work Plan of the Municipal Agriculture Office (MAOs). A FFS shall be conducted in the said Barangay.

2. Environmental Conditions & Status of the proposed quarry sites/sources/locations

All Commercial Sand and Gravel Quarry (CSAG) areas are located within the major rivers of La Union. There are more than enough quarry resources for the Balecbec-Basca FMR and Balecbec Bridge.

CSAG permit areas and holders have undergone field inspection reports to ascertain the sufficiency of quarry deposits and have passed the evaluation conducted by the Mines and Geosciences Bureau –Region I and the Provincial Government of La Union.

The project will utilize aggregates from Bauang River, Naguilian River and Aringay River. Below are the List of approved CSAG Permits areas and permit holders within or near the project area:

All permit holders are members of the Mine Rehabilitation Fund Committee (MRFC). Under MRFC is a MMT (Multi-partite Monitoring Team) which conducts quarterly monitoring of quarry areas to ensure that quarry operations are compliant to the issued Environmental Compliance Certificates (ECC).

3. Impacts on Existing Roads

Hauling of aggregates and mobilization of construction equipment could generate environmental impacts related to gaseous emissions, dust, noise, and oil spill. In addition, mobilization of heavy machinery could cause compaction of soil. To minimize these problems, the contractor should (i) locate the parking site for heavy equipment near an existing road, (ii) avoid establishment of temporary access roads for mobilizing construction equipment, and (iii) select convenient time for

moving the construction equipment to the parking area to avoid disturbance to school, primary health center, etc..

Public safety should also be prioritized. All trucks hauling to and from the project area will be required to cover the hauled aggregates/ excess construction spoils with net or thick canvass to avoid/catch aggregates falling off from the truck.

4. Grievance Redress Mechanism

An Executive Order creating the Grievance Redress Mechanism Committee has been issued by the Provincial Governor:

5. Archaeological Chance Find Procedure

An orientation/ seminar on "Archaeological Chance Find Procedure" shall be conducted by the PPMIU for the concerned project sites for the Barangay and Municipal SES Coordinator and for the Contractor and its concerned supervisors, foreman and laborers. A dedicated hotline/contact number will also be designated for easy communication.

6. ROW Compensation for and/or relocation/ Repairs of affected structures

The Provincial Government in partnership with the Municipal Local Government Units and the Barangay Local Government Unit shall provide for the rightful ROW Compensation in accordance to the law whenever applicable. It shall also assist in the relocation and/or repair of affected structures of PAPs.

7. Assistance to PAPs on dismantling/ repairs and relocation

The PPMIU thru its SES Coordinator and in partnership with the concerned municipality and Barangay and concerned contractor shall jointly craft its procedures for the dismantling , repair and or relocation of properties of PAPs.

The procedure shall define the roles and responsibilities of each stakeholder for efficient and timely delivery of assistance to PAPs.
