#### I. CONDITIONS

# A. ENVIRONMENTAL MANAGEMENT and MONITORING PLAN (EMMoP)

- The proponent shall ensure that all commitments, appropriate mitigating/enhancement measures and monitoring requirements especially those contained in the EMMoP in the EIA Report, its modifications and additional information as approved by the EMB during the EIA Report review shall be instituted and strictly implemented throughout the project implementation.
- Submit an Abandonment Plan to the EMB at least six (6) months prior to the project's abandonment. The plan shall include rehabilitation measures/clean-up, remediation of areas affected by the project, and proposed alternative projects in the area;
- That disturbed areas such as cut slopes and furrow sites resulting from the road improvement shall be rehabilitated and vegetated to restore surface stability. As such, slope protection works and guardrails shall be installed.
- Preservation of natural drainage, if practicable, shall be undertaken. If disturbed, a replacement drainage shall be constructed within two (2) months from the disturbance;

### B. GENERAL CONDITIONS

- 1. This Certificate shall cover the construction of the 6.96 kilometers Bagong Silang -Magsaysay farm to market road project technically described as 7° 44' 31.2" N Latitude; 122° 54' 10.7" E Longitude of LGU Siay to be located in Barangays Bagong Silang, Villagracia and Magsaysay, Municipality of Siay, Province of Zamboanga Sibugay in Region IX;
- 2. That in case there will be damage to life and property brought by the project implementation and/the project proponent shall be liable and must pay just and reasonable compensation to the aggrieved parties.
- 3. The proponent shall set-up an Environmental Unit who shall handle the environmental aspects of the project which shall have the following responsibilities:
  - a. Monitoring requirements as defined under the EMP;
  - b. Monitor actual project impact vis-à-vis predicted impacts and management
  - c. Make recommendations for the revision of the EMP as necessary;
  - d. Ensure that post-assessment permits are in place;
  - e. Ensure that compliance monitoring report (CMR) shall be submitted to this Office
  - f. Ensure compliance to all the conditions and restrictions of the approved ECC.

#### II. RESTRICTIONS

1. In case of transfer of ownership of this project, these same conditions and restrictions shall apply and the transferee shall be required to notify the EMB within fifteen (15)

Pursuant to Section 9.0 of P.D. 1586, non-compliance with any of the provisions of this ECC shall be sufficient cause for its cancellation or suspension and/or imposition of a fine in an amount not to exceed Fifty Thousand Pesos (Php 50,000.00) thereof.
