I. CONDITIONS

ENVIRONMENTAL MANAGEMENT

The proponent shall strictly implement the following mitigating enhancement, and rehabilitating measures:

1. Mitigating measures to minimize soil erosion, dust and noise emission during construction phase shall be effected and sanitation in all areas of the project shall be properly maintained;
2. Construction works shall be undertaken without obstructing vehicular traffic flow;
3. Spoils and excavated soil shall be properly contained and disposed taking environmental safeguards into considerations;
4. Institute slope stabilization and slope protection works;

GENERAL CONDITIONS

Further administrative conditions for the grant of this certificate shall be strictly complied:

5. Construction of roads shall be implemented in accordance with the submitted documents duly approved by the Provincial Engineer's Office;
6. The local residents shall be prioritized for employment;
7. In lieu of the Environmental Guarantee Fund (EGF), the proponent shall ensure that Contractor's All Risk Insurance (CARI) is provided to cover expenses for the indemnification/compensation of damage to life and property that may be caused by the implementation of the projects and abandonment of the project facilities related in the prevention of possible negative impacts;
8. The DENR-EMB-10 and/or multi-partite team can initiate an on-the-spot monitoring and inspection anytime without prior notice;

II. RESTRICTIONS

The proponent is strictly subject to the following restrictions:

9. No other activities should be undertaken other than what was stipulated in the Initial Environmental Examination (IEE) document. Should there be an expansion of the project beyond the project description, or any change in the activity beyond those stated in the IEE document; shall be made subject to a new Environmental Impact Assessment;

Non-compliance with any of the provisions of this certificate shall be a sufficient cause for the cancellation or suspension of this certificate and/or imposition of a fine in an amount not to exceed Fifty Thousand Pesos (50,000.00) for every violation thereof.
