## Dear Gov. Ortega:

Pursuant to the CLEARANCE issued by the Undersecretary for Field Operations dated 17 December 2014, a Special Tree Cutting Permit is hereby granted for the cutting of sixty four (64) trees to be affected by the improvement/widening of farm-to-market road (FMR) located at Brgy. Balecbec, Naguilian to Brgy. Basca, Aringay, both in the province of La Union.

This Permit shall be in accordance with existing forestry laws, rules and regulations and subject to the following terms and conditions:

- 1. To the extent possible, trees to be affected shall be incorporated in the design of the road widening/improvement project in order to minimize loss of trees;
- 2. Maximum of only sixty four (64) trees shall be authorized to be cut as described at the back of this permit;

- 3. Prior to tree cutting, a placard with dimension of 4 feet by 8 feet shall be installed within the cutting area informing the public that the tree cutting is authorized by the DENR and indicating the name of the permittee, the purpose of tree cutting and the number of trees to be cut;
  - 4. The permittee shall conduct extensive public consultations with concerned stakeholders in the area to discuss importance of the project, removal of trees affected and replacement of trees to be cut, and resolve potential issues that may be raised;
- 5. Prior to the tree-cutting operations, the permittee shall conduct assessment of trees in terms of their biodiversity, carbon sequestration potential and water storage capacity and identify mitigation measures to address the negative impacts of the tree cutting;
  - 6. Issues that will arise from the tree cutting should be addressed directly by the permittee;

- 7. Pursuant to DENR Memorandum Order No. 2012-20 dated 05 November 2012 re:

  \*\*Uniform Replacement Ratio for Cut or Relocated Trees\*\* the permittee shall replace each tree to be cut with fifty (50) seedlings for planted trees and one hundred (100) seedlings for naturally grown trees, all preferably of indigenous tree species to be donated to the nearest DENR office in support of the National Greening Program (NGP) and Climate Change initiatives of the government.
  - 8. The tree cutting operations shall at all times be under the direct supervision of the Regional Director, DENR-Region 1 and/or PENRO La Union as the duly authorized representative(s). The logs and other derivable wood materials to be recovered from the cut tree shall belong to the permittee. Logs and other derivable wood materials to be recovered from cut trees located in the titled lands shall belong to the land owners subject to payment of forest charges in the amount of \$\rightarrow\$ 2, 586.50 for the twenty (20) naturally grown trees, pursuant to Republic Act No. 7161. The permittee shall be responsible in identifying the concerned lot owners for the affected trees and payment of corresponding forest charges. In case the wood materials shall be transported by the permittee, the same shall be covered by transport documents issued by the DENR;
  - It shall be the responsibility of this Office through the PENRO La Union to monitor the permittee's compliance with the terms and conditions stipulated in this permit;
  - 10. The permittee shall be required to undertake measures during and after tree cutting operations to mitigate the possible impacts of the said activity to the locality and to the environment; and
  - 11. Violation of any of the terms and conditions of the permit shall be sufficient ground for the termination/cancellation of the permit, without prejudice to the imposition of appropriate penalties pursuant to existing regulations, and one strike policy to concerned DENR official(s) and/or personnel(s).

This PERMIT shall expire sixty (60) days from issuance hereof or as soon as the trees authorized herein have been cut/removed.

This pertains to the request dated 09 June 2014 of Gov. Manuel C. Ortega of La Union for a permit to cut trees of various species that will be affected by the improvement/widening of their farm-to-market road (FMR) located at Barangay Balecbec, Naguilian and Barangay Barca, Aringay, both in the province of La Union. The FMR improvement/widening will be funded by the Philippine Rural Development Project of the Department of Agriculture.

In accordance with the indorsement and recommendation of the Forest Management Bureau, pursuant to the Memorandum of the Executive Secretary dated 20 October 2011 regarding "similar activities" of Section No. 2, item no. 2.2 of Executive Order No. 23 Projects not covered by the suspension on the issuance of tree cutting permits include those for "Road right-of-way rehabilitation, widening of roads, airstrips and other infrastructure projects undertaken by government entities" and subject to the full compliance of the applicant with all the requirements and processes stipulated under pertinent DENR rules and regulations, CLEARANCE is hereby granted to the Regional Director, DENR-Region I to issue Special Tree Cutting Permit in favor of the applicant subject to existing forestry laws, rules and regulations and to the following terms and conditions:

- 1. To the extent possible, trees to be affected shall be incorporated in the design of the road widening/improvement project in order to minimize loss of trees;
- 2. Maximum of only sixty four (64) trees shall be authorized to be cut;

- 9. It shall be the responsibility of your Office to monitor the permittee's compliance with the terms and conditions stipulated in this permit;
- 10. The permittee shall be required to undertake measures during and after tree cutting operations to mitigate the possible impacts of the said activity to the locality and to the environment; and
- 11. Violation of any of the terms and conditions of the permit shall be sufficient ground for the termination/cancellation of the permit, without prejudice to the imposition of appropriate penalties pursuant to existing regulations, and one strike policy to concerned DENR official(s) and/or personnel(s).
