CERTIFICATE OF NON-OVERLAP

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that the applied sites for Certification of Non-Overlap, located at the Barangays of Simpak, Pinuyak and Maranding, all in Lala, Lanao del Norte for the Rehabilitation/Concreting of Simpak-Pinuyak-Maranding Farm to Market Road, does not overlap with any ancestral domain based on the processes conducted by the FBI Team leader, Mr. Buddy P. Landong.

THIS CERTIFICATION is issued upon the request of the proponent, Local Government Unit of Lala, Lanao del Norte as precondition to the approval of the application of Rehabilitation/Concreting of Simpak-Pinuyak-Maranding Farm to Market Road, over the above described area, on the following conditions listed herein below:

That Local Government Unit (LGU) of Lala, Lanao del Norte, shall execute an Affidavit of undertaking that in the event that the presence of Indigenous Cultural Communities/Indigenous Peoples are established later in the affected areas of the above project. Said applicant must comply with the salient provisions of Indigenous Peoples Rights Act (IPRA) and with NCIP Administrative Order No. 3, Series of 2012. Moreover, the NCIP reserves the right to cancel or suspend this Certificate of Non-Overlap.

Finally, this Certification is issued this 13th day of April 2015, in compliance with Section 59 of Republic Act No. 8371 or the Indigenous Peoples Right Act (IPRA) of 1997 and Section 15 of NCIP Administrative Order No. 3, Series of 2012.
